¹ This fee (which is sometimes called the interment fee) is the charge made for digging and closing a new grave, or reopening and closing an existing grave.

² In England, Wales and Northern Ireland, you will usually need to pay doctors' fees as well. This is the charge for two doctors to sign the Medical Certificates for Cremation.

TERMS OF BUSINESS:

Our Terms of Business include the following;

You must pay a deposit to the value of the disbursement fees prior to the funeral.

Unattended services must be paid in full at time of arrangement. All other accounts are due for payment within 30 days of our invoice. The funeral account invoice shall be raised a week after the provision of the service. The account is due regardless of any application for a DWP Funeral Grant, subject to probate or the deceased estate being handled by a Solicitor or Third Party, unless otherwise agreed by us in writing.

If you fail to pay us in full on the due date, we may charge you interest;

- At a rate of 2% per month or part month on the outstanding account balance.
- Compounded on the first day of each month; and
- Before and after any judgment (unless a court orders otherwise).

We may recover the cost of taking legal action to make you pay.
